Pastoral Relations Earl Reaburn reported.

The Pastoral Relations Commission continued to meet throughout the summer. The Ministry Personnel Support Committee continued to host Tuesday gatherings. The Community of Faith Support Committee will discuss providing direction to Ashmont United Church on the closing of their congregation. The Lay Leadership Support Committee has not met but is scheduled to meet by the end of this month.

The Part-time Ministry Tool is a tool to be offered to pastoral charges as they are looking for ministry personnel, particularly if they foresee that the position is going to be part-time.

We had a discussion about the wearing of masks during worship.

The regional council has no authority to mandate that masks be worn. Since the level of COVID-19 cases are different across many geographic regions, local municipalities are the ones to make those decisions. The regional council would be able to issue a letter strongly recommending the wearing of masks during worship, but the congregations have to be prepared to enforce it.

Bursary Fund Society The Bursary Fund Society have made all the appropriate motions to begin the process of disbanding. They are not yet at the point where they are comfortable splitting the money and giving half to Chinook Winds and half to Northern Spirit. The plan is to shut them down as a society and replace with a bursary fund committee that will make the decisions.

The executive is not ready to make a motion to amalgamate the CRA numbers.

Emergency Loans / Five CEBA applications were approved and one was declined.


