## Biographical Notes Submitted by the Commissioners the 44<sup>th</sup> General Council (2022) and their Alternates

### Ministry Personnel (Elected)

#### **Mary Annan, Ordained Minister, Retired**

Mary attends St. Paul's United Church in Edmonton, is a member of the Regional Council Executive, and has served on the Mission and Ministry Support Grants Committee. She has always lived and worked in Canada.

Mary self-identifies as being female; aged 50 and older; and living with vision disability, being registered blind with the CNIB. Mary has some vision, and computer programs are helpful in her being able to read documents and any reading materials that are deemed necessary for meetings, provided she can receive them ahead of time.

Mary writes, "As I am now retired, I find that I would have time to pursue interests in the church regarding accessibility, as this is a subject that has affected me throughout my life. And of course, it is much more than whether one's faith community has a ramp in or on its premises. Accessibility needs to cover many aspects of life in society, as well as in the church.

"I remember one year, at a church meeting, considering having my name offered as a possible GC Commissioner. It was promptly suggested to me that this was probably not a good idea as there is FAR TOO MUCH READING! As I reflect on this response many years later, it is my hope that we, the church, have moved away from such quick, not-thought-through, responses, and instead, look to these kinds of questions as opportunities for learning and growth for the entire body of the church. I sincerely believe we have a better handle on how we all have a part to play, no matter our abilities and/or inabilities".

#### **MPT (Mokwadi Paymann T'Dere) Basele, Ordained Minister**

MPT serves as Ministry Personnel for Grace United Church, Wainwright, Alberta.

He self-identifies as being male, aged 50 and older, and Motswana (Botswana, African), and Cisgender. MPT reads and speaks Setswana and English., and has lived in Botswana and Canada; and wishes to share his gifts with the wider church and also learn more as we navigate a difficult terrain during the pandemic.

MPT was born, bred and socialized in the United Congregational Church of Southern Africa. He served as a Sunday School teacher, a Youth member and leader, Church Secretary, then joined the Ordained Ministry in 1998, and served rural and urban churches. MPT was employed as Synod Secretary for the Botswana Synod of the UCCSA. As the Synod Secretary, one is involved in the life of church through committees and ministries making decisions (collectively, consensus, consultations), recommendations and serving our communities and planting churches. He represented the church in government, private sector and other institutions.

MPT writes, "I believe I will represent the church, support its work and be part of this great movement in Canada and the world as gospel commissions us. I want to be part of those who are supporting communities of faith now and during the pandemic and finding better ways and how to be a relevant church post-COVID.

"My strength, inter alia, is listening, supporting others, working with others and availability."
