Funds transferredAt some point in the last year, the Student Bursary Fund was transferred intofrom Student BursaryNorthern Spirit Regional Council. The fund's assets were held in Frontier Capital andFundThe Alberta Treasury Branch and remain there after their transfer.

The Executive Minister and Financial Administrator are signing authorities on the Frontier Capital account. Mary Annan, Kathy Jackson, and Earl Reaburn are signing authorities on the Alberta Treasury Branch account.

The funds in the Alberta Treasury Branch meet the requirements of the Finance Guidelines as the funds are guaranteed by the Province of Alberta. However, the Signing Authorities are not consistent with the guidelines.

That Northern Spirit Regional Council Executive agrees that upon the maturity of
GICs and term deposits held at Alberta Treasury Branch, we will close the account.

We had a discussion on whether to retain funds in Frontier Capital, which are not guaranteed or protected in any way and therefore does not comply with our policy. We either need to change where the funds are kept or change the policy.

Donna Kline agreed to investigate the quality of other equity funds and come back with proposed changes.

Financing In-personIt has been decided that the regional council will hold in-person regional meetingsAnnual Meetingsevery three years, with online meetings held in other years. The next in-person
meeting of Northern Spirit Regional Council will be in 2024.

The cost of an in-person meeting is higher than the cost of online meetings. If the budget is higher every third year, there may be requests to increase expenditure to these levels every year, which we believe would be unsustainable. Sources of funding may also change.

It is proposed that an in-person meeting fund be set up and that the Executive review a five-year strategic plan to determine if there are risks or opportunities for funding expenditures that should be investigated.

- Pastoral RelationsStarting February 9th, the Pastoral Relations Commission is planning a WednesdayCommissionworkshop for Pastoral Relations Liaison training. Lay people are welcome to attend.

Communities of Faith Support Committee	The Communities of Faith Support Committee would like to develop a way for pastoral charges to engage in conversation about partnerships with other congregations. As more and more ministry personnel retire, move, and relocate, it's becoming more urgent.
	A small task group has been formed with a member of the Pastoral Relations Commission, the Property Commission, and the Community of Faith Support Committee.
Ministry Personnel Support Committee	The Ministry Personnel Support Committee met last week.
Support Committee	One point of discussion was receiving guidance from the wider church in unusual circumstances, such as the arrival of Coronavirus Omicron variant, and how to proceed with Christmas Eve services. The guidance being offered is different across regional councils.
	The Executive wanted to note that the structures set up between regional councils are very different and we aren't encouraging a comparison between them. We acknowledge that people are exhausted of making decisions. The issue of guidance around unusual circumstances feels like a pastoral care situation, not a question of polity.

Executive Minister's Report	Shannon McCarthy reported.
Ashmont United Church	Ashmont United Church has agreed to gift their building to Acimowin Opaspiw Society, who has many programs around healing for survivors of residential schools.
GC44 Commissioners	The first session of GC44 is February 13, 2022. Listening session are in March, April, and May, discussion sessions will be in June, and voting happens in July. There will be time to register to gather commissioners for discussion around specific topics.
	General Council is using a new virtual meeting system for GC44 called Pheedloop. To be efficient, training will be provided for all three regional councils at the same time.
Salary scale changes	Based on the decision to eliminate the two-tiered salary schedule, General Council has agreed to cover the salary differential for 2022.
Kathy Jackson	After 25 years of service, Kathy Jackson is retiring in September 2022.
	Kathy has been a tremendous resource person and does exceptional work. We will begin work to find someone to move into her position and glean as much knowledge as we can before she retires.

Incorporated Ministries	There was nothing new to review from incorporated ministries.
Engaging Communities of Faith	We had a discussion on a proposal to engage communities of faith with questions that would give us a picture of the issues of the regional council.
	The information learned from the proposed questions is already available, but not all in the same place. Before going to communities of faith, we could start with combining the knowledge and data between our resources. We might also consider holding a meeting between all the regional council's commissions and committees.
	A lot of us have past knowledge but we want to make decisions based on the current state of affairs. The questions posed and the answers provided would be helpful to get an idea of what is going on in the regional council.
	We agreed to reflect on this discussion and come back to it at a future meeting.
Justice & Communications	We will hear an update from Justice and Communications at a future meeting.
Nominations	Marilyn Carroll has contacted an individual who expressed interest in the anti-racism proposal and is waiting for a response.
	If any members on the Executive are willing to serve a second term, please let Marilyn know.
	Marilyn Carroll has completed two terms on the Executive and will be finished in June.

Adjournment	Gord Waldie adjourned the meeting at 12:05 PM.


