Cluster Funding Request

There was a cluster request from Robertson-Wesley United Church for June 22-24 event. They are looking for \$3000. On their application it is noted that there would be a \$10,000 registration expense? That doesn't make sense. Also there is a \$26,000 salary expense. Is this a network or cluster? Is it a community event? If it is not deemed a network or cluster, can we take money from Mission & Ministry Fund or Legacy Fund? Chloe mentioned that they were hoping to fall under Affirming Network for funding.

It seems to be the consensus that we should support this event with funding but will decide where the money comes from later.

We need better clarity on what is a network?

Together We Worship

This is a \$4000/year expense.

Should we continue to support this? We had the same conversation two years ago. If individual churches are using this resource instead of paying somebody to do pulpit supply, should we be paying for this (and not pulpit supply)? Money came from Presbytery (\$10k) to fund this. This money is now gone.

There are free resources online that people can use nowadays. Rural Connect is also an option.

In Rural/remote communities, travel costs can be higher. Should there instead be an application process for those congregations who have to pay a higher supply rate.
