STAFF REPORTS

Executive Minister

Getting ready for a centennial celebration in Saskatoon next week, followed by our AGM in Edmonton.

Towards 2035 – letter went out to ministry personnel and pastoral charges. We are now able to discuss this. It will be discussed as a workshop at the AGM.

Ministry personnel received an evaluation survey regarding the restructuring. Encouraged to please fill it out.

Each region was asked to submit a 1 minute video to the centennial celebration committee. Thank you to staff who helped gather those videos. Our logo was also requested to create banners

We have one proposal for the regional council meeting. This is a request to give marriage license to sacrament elders and lay worship leaders. Right now this isn't technically possible under the provincial rules. So this will need to be a discussion at the AGM.

To do:

 Shannon and Adam to prepare a fact sheet for the AGM to help with information that would be helpful with the proposal

Pastoral Relations Minister

Adam will have a detailed report in the workbook for the AGM. As well as a display.

There are two pastoral relations committees that have not met for the past two months because they cannot fulfill quorum. This means a lot more work is being pushed up to the commission to deal with.

Justice & Communications

Justice and Communications report to 14 May 2025 NSRC Executive

Centennial: FINALLY taking off through local events that are creative and numerous. I guess our resources were ahead of the curve. Leanne is very busy with requests despite our attempts to get ahead of this.

We submitted a three-Region three minute video as part of the St John's national Centennial service. I will try to access the entire national video in advance of the St John's service.

Here from the Beginning display and work: I have been very happy to support this work with the leadership of Paul Walfall and other Black Clergy Network members. We will need to lean into the July 27 launch at Pilgrim UC in Edmonton, which aligns with Emancipation Day. Upcoming work includes promoting the many stories this work is surfacing; and working on how to get the display moving through the country throughout this Centennial year.

Affirming Tri- Region gathering on Preparing for Pride May 13 drew 30 people from all three Regions. This created a lot of energy- alone we would have had low attendance, and people were energized by seeing people from AB to NW Ontario. The three Regional Affirming committees are interested in continuing to look at this shared model. Holding regular space for conversation, relationship, and support is something all three Regional committees want to We had to postpone the May 10 Affirming Donut meeting (the circle around Edmonton) because of low response; the committee is going to visit the two congregations that wanted to come, and has rescheduled a donut and timbit meeting Oct 25. We look forward to the May 30 event on the experiences of those targeted by AB's transphobic legislation and welcome any promotion help. Anecdotally, the committee is hearing that hundreds of letters have

been sent from communities of faith and members as a result of the action and Executive letter on the legislation. A number have reported that they held letter-writing sessions after church. So far we have only received one response from government, from Sports, and they simply repeated what the legislation is.

Being Good Relations Separatism: There is great concern with the separatist push led by a minority in AB. The network will be bringing a request and content suggestions for a letter from the Regional Councils to the Treaty chiefs and organizations who are reminding separatist groups and the AB government that the province is entirely under Treaty between First Nations and Metis and the federal Crown. They suggest it be cc-ed to the AB government; the intent would be to lend the United Church's public support to Indigenous Nations Treaty holders. More information to come. Nuclear power: This issue never goes away. We're now seeing a re-tread of this decades-old plan, this time targeting the Peace River area. The East Coast regions of the UCC are making a submission to the formal federal process and asked if we could do the same. However, the process closes today. Given the complexity, learning curve, and inability to talk with local communities of faith and First Nations on this timeline, I asked "UCC East" to send me their submission so we can start the learning process.
