Pastoral Relations Commission

The Pastoral Relations Commission recently met for their annual Visioning and Governance meeting. They discussed the functionality of the sub-committees and their terms of reference (attached) and came to the following consensus decisions:

- To recommend to the Executive that the Community of Faith Support committee's terms of reference be adjusted to include **only**: to provide oversight and to receive and review regular self-assessment reports from C of Fs, and any work related to the development and implementation of oversight and self-assessment;
- 2. To recommend to the Executive that the Pastoral Relations Commission takes on the remainder of this committee's work as named in the terms of reference;
- 3. & To communicate to the Executive the Commission's strong concerns about the functionality and viability of the other two support committees (Ministry Personnel Support and Lay Leadership Support) as they currently operate.

STAFF REPORTS

Executive Minister

Shannon would like to take a look at how the Executives are functioning in the three regions and how we can include the Towards 2035 information. Chantal has arranged a meeting with the Chair from all three regions for late August.

Interviews are starting tomorrow for the Finance Admin position. Heather has agreed to stay with us until August 15 to help with the transition.

Shannon is working on the job descriptions for the other job positions we have discussed and agreed to as an Executive.

The Chinese United Church has been having people camping out inside. We are going to need to put a plan in place as the UPRC stuff is moving fairly slowly.

The AGM went really well. Thank you to all who were a part of it and helped with planning.

It was an honor to represent the three regional councils in St. John's at the 100th anniversary event.

Will be leaving on Tuesday for holidays. Returning after General Council.

Pastoral Relations Minister

Adam reported.

We have had two requests for change of pastoral relationship. The first is Deanna Cox at Killam and Daysland happening at the end of Summer. The second is Blessing from Slave Lake Ecumenical Shared Ministry. We will be getting a liason up and running to begin that process.

Millwoods will also be rebuilding a job description for their community of faith.

Adam is working with Fort Nelson as they discern the best course going forward.

Fort St. John has resubmitted their paperwork. Their admissions minister appointment fell through due to immigration. They have also asked to be a SME cite.

Irma and Viking United Churches have been searching for awhile and a recent appointment opportunity has fallen through.

Some of our ministry personell who have been on medical leave are returning this week or next.

We had two renewals of appointments: Marilyn Carroll with South Peace Pastoral Charge and Harold Iams with Spirit River Pastoral Charge.

On Saturday January 14, the Pastoral Relations Commission hosted an event at Southminster Steinhauer United Church. There were 16 communities of faith from the Edmonton Area in attendance, about 40 people. They spoke about different ways to collaborate, keeping in mind the Towards 2035 report.

Justice & Communications

Julie reported.

Thank you to the amazing folks, especially the AV team, at the AGM. It was a wonderful gathering.

The anniversary video was obtained and shared.

Communications have gone out regarding communities who are being affected by wildfires. This is our new normal and it has huge implications for all three regions. Climate change and the consequences of it need to be addressed further. It might be time to gather a few representatives from each region to discuss things such as communication, funding, trauma support etc.
